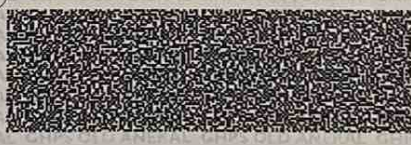

Between

GHPS, Old Anekal, Bengaluru, Karnataka herein after called as First Party.

And

Aikya Trust, located at 5104, Prestige Nottinghill, Sy no 9 Kalena Agrahara, Bengaluru, Karnataka, herein after called as Second Party, for a period of One year w.e.f. on 17-06-2023 and renewable on year to year basis.

Now it is hereby agreed by and between the parties as follows for the consideration hereinafter mentioned:

1. WHEREAS the First Party is desirous of seeking support to start LKG & UKG classes in the school and also need support to improve learning outcome for Class I, Class II and Class III students (for age group 6-8)

2. AND WHEREAS the Second Party is desirous and agreed for providing following support to the school
 - To hire one teacher and one support staff for LKG and UKG classes (pre-school)
 - To hire one teacher for conducting activity-based learning, for Class I, Class II and Class III, to improve learning outcome
 - Provide necessary textbooks/workbooks for LKG and UKG classes, wherever necessary
 - Provide foundational/core activity-based learning materials for age group 3 to 8 years
 - Provide Online or Physical training for basic courses to hired teachers like phonics etc., if there is a need
 - Provide guidance on academic front to meet objective of quality education, from Aikya Trust academic advisors/experts, if necessary & as and when required

- 2.1 The Second Party should have members with social commitment and not run by an individual. The Organisation working with commercial interest and participating in anti social, unlawful activities are prohibited completely in participating in this programme.

- 2.2 The First and Second Party will jointly evaluate teachers to ensure appropriate selection of candidate.

- 2.3 **Monitoring Progress:** The Second Party members and its academic advisors will be given appropriate support by first party to monitor and measure outcome of pre-school and outcome of activity-based learning for Class I, Class II, & Class III, on regular basis (weekly or fortnight basis). If second party observes any performance or punctuality issues with teacher, they are authorized to recommend change of teacher and new teacher will be selected jointly by first and second party. The intent here is to ensure the outcome of quality education intended by second party is achieved

3. **Tenure/Duration** - The agreement is effective from 17-06-2023 to 31-03-2024. The agreement shall come to an end on the expiry of the said period i.e. 31-03-2024 and no separate notice shall be served in this regard.
4. **Renewal Clause** – The renewal of contract shall be subject to the outcome achieved during first contract.
5. **Notice period** - The First Party can terminate this agreement, giving 2 months', and providing valid reasons for termination
6. **Notice period** - The Second Party can terminate this agreement, giving 2 months', if provided resources (teachers/support staff) and academic content is not used for the academic purpose stated in point no. 2
7. **Arbitration:** In the event of any dispute arising out of the contract between the parties here to, the same shall be referred to the sole arbitration of the State Government or any officer appointed by the State Government on its behalf. The proceedings held by the arbitrator in making award will be in accordance with the provisions of Indian Arbitration and Conciliation Act 1996 or any statutory amendments thereof. The award of the arbitrator shall be final and binding on the parties.
8. **Payment Schedule:**
Approx. cost for two teachers and one support staff is expected to be Rs. 3 lakhs

50% payment (Rs. 1.5 lakh) will be done by Jun 25th, 2023
50% payment (Rs. 1.5 lakh) will be done by Sep 25th, 2023

The deposits will be done to school joint account held by HM and SDMC. School is expected to disburse the salary to the hired teachers and support staff from this account on a monthly basis. First party will provide receipt of the payment to the second party.
9. **Activity-based learning material** will be provided by or before July 25th, directly by second party
